Food insecurity in the U.S. has risen to 44 million people in 2022, including 13 million children, according to the U.S. Department of Agriculture. An increase of 31% for individuals and 44% for children from the previous year, the highest rate and number since 2014 and the largest one-year increase since 2008.

The Bill Emmerson Food Donation Act was passed in 1996 to fight food insecurity and food waste but it only covers free food donations to non-profits. As a result, around 350 food banks across the U.S. shoulder the immense burden of helping their communities become food secure, often working with limited resources and volunteers.

We need modern innovations to address such staggering increases in food insecurity

The Food Donation Improvement Act (FDIA) was passed in 2023, with bipartisan support and collaboration across non-profit and corporate partners to increase food rescue and drive innovations. The FDIA expands liability protections and tax deductions to incentivize businesses and allows needy individuals to participate directly for the first time.

Our mission is to broaden access to food security by delivering incremental value to the stores that donate food, empowering non-profits to scale up and democratizing food rescue for families and individuals.

- **Prioritize without waste** Resources and volunteers can focus only on items required for the food bank, knowing that the rest can still reach needy individuals via direct donations from the store.
- Relieve pressure on food banks Local stores can become food rescue locations for individuals to directly pick up donated food, supplementing food bank locations and operating hours.

Food insecure families and individuals

- Equitable access to food donations Grocery stores greatly outnumber food banks. With direct donations from stores, needy families and individuals can access food security from more locations that are closer to them and open for longer hours.

Changes to the law

- Only free food donations to domestic non-profits can receive liability protection and tax deductions
- Confusing laws and liability concerns result in missed opportunities to rescue wholesome food



- Free food donations and reduced price clearance food to domestic non-profits and directly to needy individuals receive liability protection and tax deductions
 - Creates additional channels and monetary incentives for food rescue

Discovery

- Cannot view what donations are available at each store location and plan routes
- Inefficient use of precious non-profit resources and volunteers
- Stores must throw away food that is not picked up by non-profits



- App with real-time view of items at each store. Find, reserve and pick up free food donations and purchase clearance items
- Stores make donation inventory visible
- Non-profits can use resources effectively
- Individuals can find food to rescue directly

Convenience and Equity

- Compared to grocery stores, food banks operate for fewer hours per week
- Challenging to find volunteers year round
- Working adults, students and homebound may not make it during these limited hours
- Food rescue may not be equitable



- Supplement food banks with direct food rescue from grocery stores
- Stores become new food rescue locations that are open for longer hours all year long
- Greater choice of food to rescue
- Direct donations reduce theft at stores

Environment and Sustainability

- Labor, fuel and energy can be spent many times over on the same food item, passing through many hands before it reaches the needy individual
- Can create preventable greenhouse gas emissions



- A needy individual living near a store with donation or clearance food items can directly pick it up without a long commute
- Donated food items can pass through fewer hands and locations, saving energy
- Greener for the environment

Central Management

- Each store and local non-profits maintains bespoke partnerships
- Difficult to observe food rescue trends and insights from local to a national scale
- Lacking unified dashboards and support services to manage relationships and goals
